

3. Conclusion of Training

## Racehorse repurpose and retraining conditions

If your horse is in our racehorse repurpose program you agree to forward all relevant medical history including past past injuries to Circle J Horsemanship

You agree to Circle J Horsemanship conducting a full veterinarian check before your horse is available for rehoming at your expense

You agree to Circle J Horsemanship deducting 50 percent of rehoming price with owner being paid the remaining 50 percent into there nominated account

You agree for Circle J Horsemanship to advertise , promote and assess potential buyers for your horse .

You agree to sign your ex racehorse to nominated buyer once all money has changed hands

You agree that Circle J Horsemanship will reassess your ex racehorse each 6 weeks and in the event Circle J Horsemanship feel your horses needs longer in its retraining program to be successful in its new equine journey you agree to further training. You as the owner will be notified by Circle J Horsemanship if this is needed
