

CIRCLE J HORSEMANSHIP - Horse Training Terms & Conditions

1. Agreement Overview

These Terms and Conditions (the "Agreement") constitute a legal agreement between you (the "Client") and CIRCLE J HORSEMANSHIP, a horse training service provider (the "Trainer"). By engaging in our horse training services, the Client agrees to abide by the terms set forth in this document.

2. Services Provided

CIRCLE J HORSEMANSHIP provides horse training services for various disciplines, including but not limited to groundwork, riding, behaviour modification, and specialised training. Services may be tailored to the needs of the individual horse and/or rider. Detailed descriptions of the services will be provided prior to the commencement of training.

3. Duration and Scheduling

The training schedule will be agreed upon by both the Client and Trainer. Training sessions are typically scheduled based on availability and agreed-upon training packages. CIRCLE J HORSEMANSHIP reserves the right to modify the training schedule with prior notice if circumstances necessitate it.

4. Fees and Payment

The Client agrees to pay for training services as outlined in the pre-agreed training package or invoice. Payments are due before completion of the services, as stated in the agreement. CIRCLE J HORSEMANSHIP accepts payments via cash, check, or electronic methods. Additional charges may apply for services outside the scope of the original agreement, including but not limited to travel, overnight boarding, or special materials.

5. Cancellations and Rescheduling

Cancellations must be made at least 24 hours in advance. If the Client fails to cancel or reschedule within this time frame, they may be charged a cancellation fee. CIRCLE J HORSEMANSHIP reserves the right to reschedule or cancel sessions in case of emergencies or adverse weather conditions. In such cases, the Client will be notified as soon as possible.

6. Horse Health and Safety

The Client must ensure that the horse is in good health and free from any known illness or injury that could affect its ability to participate in training. The Client is responsible for providing all necessary documentation regarding the horse's health, vaccinations, and medical history. CIRCLE J HORSEMANSHIP reserves the right to refuse training for horses deemed unfit for training due to health or behavioural issues.

7. Horse Ownership and Liability

The Client affirms that they are the rightful owner of the horse(s) being trained or have the necessary authorisation to engage CIRCLE J HORSEMANSHIP on behalf of the horse's owner. The Client accepts full responsibility for any injury, illness, or damage caused by the horse to themselves, other animals, or any person during the course of training. CIRCLE J HORSEMANSHIP will not be liable for any injury or damage caused by the horse during training sessions.

8. Liability Waiver and Indemnification

The Client agrees to hold harmless and indemnify CIRCLE J HORSEMANSHIP, its

employees, agents, and representatives from any and all liability, claims, damages, losses, or expenses arising from injury or property damage caused during training or handling of the horse. The Client acknowledges that training horses involves inherent risks and agrees to assume those risks.

9. Conduct and Behaviour Expectations

The Client agrees to conduct themselves and their horse in a safe and respectful manner. Any abusive, disruptive, or dangerous behaviour by the Client or their horse will result in immediate termination of training services, with no refund for services rendered. CIRCLE J HORSEMANSHIP reserves the right to refuse or terminate any training if the safety of the horse, Client, or Trainer is at risk.

10. Photographs and Video

The Client consents to the use of photographs and video footage of their horse for promotional or educational purposes by CIRCLE J HORSEMANSHIP. The Client may request that their horse's identity be kept confidential if desired.

11. Refund and Satisfaction Guarantee

CIRCLE J HORSEMANSHIP strives for the satisfaction of every Client. If the Client is dissatisfied with the services provided, they should immediately notify the Trainer. Depending on the circumstances, CIRCLE J HORSEMANSHIP may offer a refund or additional sessions at no charge. Refunds will not be provided after the training service has been rendered unless agreed upon in writing.

12. Governing Law

This Agreement shall be governed by the laws of the state or jurisdiction in which CIRCLE J HORSEMANSHIP operates. Any legal disputes will be handled in the courts of that jurisdiction.

13. Amendments

CIRCLE J Horsemanship reserves the right to modify or amend these Terms and Conditions at any time. Any changes will be communicated to the Client in writing, and continued use of services will be considered acceptance of the updated terms.

14. Entire Agreement

This document constitutes the entire agreement between the Client and CIRCLE J HORSEMANSHIP regarding horse training services. Any prior agreements or understandings, whether written or verbal, are superseded by this Agreement.
